













## Modern Slavery Learning Resources

For all that work with children, young people, and families, including adults that might be at risk, who need to know more about Modern Slavery and how to respond. These resources provide basic learning to raise awareness and improve understanding of Modern Slavery. Practitioners working with victims or managing cases will require more in-depth training.
